Is F2F continuing to drive you crazy? Is obtaining F2F documents from your physicians still a nightmare? F2F documentation has been the focus of the Comprehensive Error Rate Testing (CERT) program & the findings are clear: most documentation is not sufficient. The Office of Inspector General's study on F2F documentation recommends that CMS provide clearer instruction and standardized documents to assist in obtaining the adequate documentation needed. The MACs are closely monitoring the F2F forms and are seeing denials in up to 50% of the documents submitted.

This teleconference will bring agencies up-to-date with CMS' current decisions regarding F2F documentation, offer guidance taken from CMS on how to determine if the documentation you have will stand up to medical review, provide an overview of some of the latest clarifications on F2F requirements as well as examples of adequate versus inadequate documentation and some tips to try to keep your F2F encounters from totally disrupting your agency's operations and cash flow. You will receive up-to-date information on what the agency can and cannot add to documentation and Judy will provide resources to assist you in making the best decisions.
