

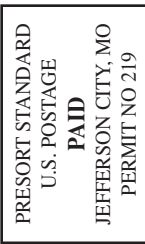
What Happens Next?

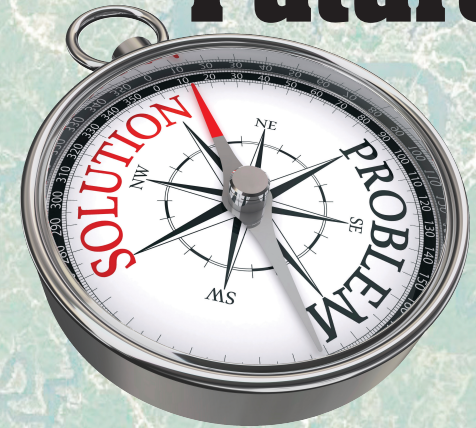

- **Provide a title** for your submission. We encourage titles that reflect the conference theme: **“Navigating the Future”**
- Indicate the target audience for your presentation.
- Identify level of learner the material is intended for—intermediate, advanced, etc.
- List the duration of the presentation: **90 minutes is preferred.**
- Provide your name and contact information: address, phone, cell, whatever else we need to be able to reach you. Also include your current employer and your title.
- If you will have a co-presenter, we need to know name and contact information.
