The Patient Driven Groupings Model (PDGM) went into effect January 1, 2020 for Home Health Agencies. This is the most substantial change to the home care industry reimbursement structure since the introduction of the current Prospective Payment System (PPS) in October 2000. The new payment model dramatically impacts agency operations, processes and performance. Agencies must develop and implement plans to successfully transition to PDGM. This session will discuss PDGM overview, what the plan includes, key areas including OASIS Functional Impairment items, strategies and processes to be sure you have in place now that PDGM is here!

Understanding the impact of Diagnosis Coding is crucial to your agency’s success under PDGM. Two of the five PDGM subgroups are directly linked to coding. Clinical Grouping and Comorbidity Adjustment.
