- PDGM Functional Score items used for payment
- Quality items used for Quality of Care Star rating and IMPACT Act measures
- Items used for Value-Based Purchasing (VBP) coming to all in 2022
- Key items used for risk adjustment of quality measures

Teresa will provide CMS item guidance along with practical assessment techniques and documentation tips to ensure OASIS data you can trust, leading to accurate quality measurement and payment.
