Home Health Value-Based Payments also emphasize the impact of quality outcomes based on accurate reporting of behaviors, dyspnea and GG functional OASIS items. Join us as industry expert and physical therapist Cindy Krafft connects the dots between these industry challenges and trends to help home health providers attain optimal outcomes based on intentional care planning and accurate OASIS data collection which ultimately impact agency HHVBP outcomes and STAR ratings.
