Description: Beginning in November 2017, Medicare and Medicaid providers – including home health and hospice – must meet a host of new requirements designed to ensure that they have the necessary planning in place to provide safe care for their patients, regardless of what type of emergency may occur. This series of six one-hour webinars will provide in-depth knowledge of the new requirements that home health and hospice organizations are subject to, with specific focus on: an overview of the regulations, starting the agency-specific plan, building the plan, development of policies and procedures, communication, and testing and training.

Program Goals: Through attendance in this web series, participants will increase their understanding of the new federal emergency preparedness requirements that are part of the home health and hospice Conditions of Participation (CoP) and become knowledgeable in how to apply the federal requirements for disaster preparedness in their home health or hospice agencies.
